## Ordinance No. 11.09.2021 repealing Ordinance 1976-2 regulating the use of firearms

Supervisor Braddock made a motion to adopt Ordinance No. 11.09.2021 repealing Ordinance 1976-2 regulating the use of firearms; seconded by Supervisor Bierly, MCU.

## **Preliminary 2022 Budget**

Chairman Yohe explained the preliminary 2022 Budget to residents in attendance and Supervisor Bierly made a motion to approve the preliminary 2022 Budget; seconded by Supervisor Braddock, MCU.

# **Generator for Waterville Fire Company**

Chairman Yohe explained that the 2021 Budget included assisting the Waterville Fire Company with the purchase of a 35KW Standby Generator for the Waterville Fire Hall stating that the old 17KW generator will be moved to the fire company building in Cammal. Chairman Yohe noted that the lowest quote for the generator was from Tiadaghton Electric, LLC and the Township's share of the invoice is \$8,894.00.

Chairman Yohe made a motion to approve payment to Tiadaghton Electric, LLC in the amount of \$8,894.00 for one-half the cost of the generator; seconded by Supervisor Bierly, MCU.

#### 2022 TVRPD Police Contract

Supervisor Bierly made a motion to approve the 2022 TVRPD Police contract at the same rate as the 2021 contract, \$2,083.33 per month, not to exceed \$25,000.00; seconded by Supervisor Braddock, MCU.

### New Backhoe/Loader

Roadmaster/Supervisor Bierly explained that the Township will be trading in the 2010 Case Backhoe, which is in need of repairs, noting that the trade-in value is \$35,500.00, on a new Case 580 Backhoe/Loader under the CoStars Contract at \$171,041.00 after the trade-in and discounts the final cost for the new Case Backhoe/Loader is \$84,560.00.

Chairman Yohe made a motion to approve the purchase of the new Case 580 Backhoe/Loader and trade-in the 2010 Case Backhoe/Loader, at the final price of \$84,560.00; seconded by Supervisor Bierly, MCU.

# **Garage Lights**

Supervisor Braddock said he received a complaint from John and Lou Ann Gasperine about the brightness of the lights of the garage which can be seen from their home.

A discussion ensued and the possibility of installing motion sensors and/or installing an infrared camera.
