The Cummings Township Board of Supervisors held their monthly meeting on May 10, 2022, at 6:00 pm at the Cummings Township Municipal building, with Walter Braddock and Richard Bierly present

Pledge of Allegiance

Public Participation:

Resident Karen Purvis pointed out that the Pine Creek Valley Preservation Association newsletter recognizes Brown, McHenry and Watson Township but did not include any information about Cummings Township or its website.

A discussion was held and it was the consensus of the Board to follow up with Donna Pearson of the Pine Creek Valley Preservation Association.

Resident Jim Mitcheltree inquired as to who the township hired to take care of enforcing the zoning ordinances and who is responsible for issuing RV Permits.

The Supervisors explained that Jeff Markley, Zoning Liaison, is responsible for issuing RV permits and Roger Hoy of Hoy Inspections takes care of code enforcement, issuing zoning permits and UCC inspections.

Resident Connie Mitcheltree said there is an individual in the neighborhood who continues to burn dog feces and has dogs that bark continuously.

Sgt. Crawford said an officer did speak to this individual previously about the issue and recommended that residents call 911 while he is burning, or when the dogs are barking, and officers will come up and take a statement and hold him accountable. If there is not an ordinance in place, the individual could be charged with disorderly conduct under the Pennsylvania Criminal Code.

Recreation Committee Report:

Recreation Committee Member Karen Purvis reported that Donna Bierly has resigned from the Recreation Committee.

Karen also reported that both Rick and Donna Bierly gathered information needed for Lillie Langlois, of the Recreation Committee, to prepare a grant application on behalf of the Committee for Lycoming County's Act 13 Mini Grant for Parks and Recreation Program and the Recreation Committee was awarded \$16,400.00 in grant funds for playground equipment.
