CUMMINGS TOWNSHIP MEETING AUGUST 9, 2022

The Cummings Township Board of Supervisors held their monthly meeting on August 9, 2022, at 6:00 pm at the Cummings Township Municipal building, with Michael Yohe, Walter Braddock and Richard Bierly present

Also in attendance: Sgt. Michael Crawford of TVRPD, Donna Bierly, Tom Mussington, Karen Purvis, Paul Sattazahn, and Bub Rainey

Lord's Prayer

Public Participation:

Karen Purvis of the Waterville Water Association reported that the water table is extremely low and the Waterville Water Association has placed voluntary restrictions for water usage and believes those restrictions will soon become mandatory. She also suggested individuals who have private wells should also be watching their water usage.

A discussion was held about making people aware of the water situation and Donna Bierly said signs have been posted around town and Karen requested that water restrictions be placed on the Township website. Tom Mussington suggested placing a notice on the Fire Company's sign.

Paul Sattizahn reported that 4-wheelers are crossing the state highway on weekends near his residence.

A discussion was held, and Sgt. Mike Crawford suggested Mr. Sattizahn call 911 and officers will try to address the issue. However, if officers do not arrive in time to stop the individuals, he said it would be beneficial to get license plate numbers of the vehicles.

Donna Bierly reported that the plaques for the bells have been installed at the entrance of the township building.

Tom Mussington reported that McHenry Township is purchasing a small electronic speed sign to place along the state road in their municipality in an effort to cut down on speeding.

Recreation Committee Report:

Karen Purvis reported that the musical instruments have been installed at the playground.

Karen also reported on the bench donated in memory of Spence Graybill that is in poor shape. Donna Bierly reached out to Spence's nephew to let him know that the bench is in poor condition, and he is willing to purchase a replacement bench that is made out of composite material.

Karen said the playground is now full of playground equipment and both the pickleball and basketball courts and suggested the focus now be on maintaining the playground.

A discussion was held regarding the restrooms to be installed by DCNR at the playground and the anticipated cost of maintaining the restrooms.

Karen Purvis also mentioned that parking for the Waterville Fire Company's Apple Butter Festival may be an issue this year and suggested the fire company start now to address parking for the festival.
